

**Please read the complete rules for the amateur photo contest of the 3rd Annual Choctawhatchee Estuary Family Festival before entering.**

## **OFFICIAL PHOTO CONTEST RULES**

*No purchase or payment necessary to enter or win.*

### **Entrant Eligibility**

Mattie M. Kelly Cultural & Environmental Institute employees, Committee members, and their immediate family members are not eligible. Immediate family includes only spouses, parents and children. All entrants must be amateur photographers. Amateurs are considered individuals who do not make a living selling their work. Final designation of amateur status is at the discretion of the judges. Entrants deemed not an amateur by the panel of judges will be disqualified.

### **Photo Eligibility**

All photos must be taken in the Choctawhatchee Watershed within the last three years. The photo subject must be relevant to the Choctawhatchee Watershed and be a realistic representation of the natural heritage of the Choctawhatchee Watershed.

### **Number of Entries**

Each entrant may submit up to three (3) photos.

### **Photo Formats**

Entry photographs may be color or black and white. Entrants must submit a high resolution digital image (at least 300 dpi) of photograph(s) on a CD. Please attach a label to the CD with your name and address.

### **Photographer/Copyright**

Entries must be submitted by the original photographer. Do not submit a photo taken by someone other than yourself. You must be the sole owner of the copyright of any image submitted. Your submission of the photo and entry form is your guarantee that you are the author and copyright holder of the photo.

### **Photo Subject Restrictions**

Photos must be appropriate for posting on a public website or in a calendar available to the public. Obscene, provocative or otherwise questionable content will not be considered. The Mattie M. Kelly Cultural & Environmental Institute retains sole discretion as to what constitutes inappropriate content. *Photos containing recognizable people must be accompanied by a signed model release form (attached).*

### **Return of Photos**

Photo CDs will not be returned.

### **Ownership/Use Rights**

Photographers retain the copyright to their photographs. By entering the contest, photographers agree to have their submitted photograph displayed at the 3<sup>rd</sup> Annual Choctawhatchee Estuary Family Festival without any fee or other form of compensation, and agree that winning photos

may be displayed in a "past winners" photo gallery, and copies of the photograph may be retained for archival and organizational promotional purposes. Photos will be credited to the photographer named in the entry form. Entries (including non-winning entries) may be selected for display or use on the Mattie M. Kelly Cultural & Environmental web page and in a photo calendar; entrants will not receive financial compensation for photos used in these ways. Entrants agree that they may be contacted to obtain permission for use of photos in this way. In the event that ownership of any photograph submitted to us is contested in any manner, the Mattie M. Kelly Cultural & Environmental Institute retains the discretion to disqualify that photograph and discontinue use of the photograph.

### **How to Enter**

The photo CD may be mailed or hand delivered along with completed entry forms to the Mattie M. Kelly Cultural & Environmental Institute of Northwest Florida State College (see further instructions below). All entries must include a CD containing a high resolution TIFF digital image (no lower than 300 dpi) of that print (label CD with name and address), and a completed contest entry form. Entries must be received by Friday, March 24, 2010 at 5:00 p.m. CST.

### **Judging**

Entries will be judged on the basis of creativity, photographic quality, and effectiveness in conveying the beauty and/or unique character of the Choctawhatchee Watershed. Judges will be looking for entries that are realistic and represent the natural heritage of the Choctawhatchee Watershed. A panel will judge the entries and all contest decisions are final. Entries that fail to comply with the Official Contest Rules will be disqualified.

### **Winners**

Judges will select a first, second, and third place winning photo. If fewer than ten eligible photographs are entered, a first place winner only may be named. In addition, one or more honorable mention winners may be selected or photo categories may be created with an especially large numbers of entries, at the discretion of the judging panel. If photo categories are created, various place prizes will be awarded for each category. Winners will be notified approximately 2-3 weeks after the contest deadline by phone or email using the information on the entry form. Winning photographs, along with the photographer's name and information about the photo will be announced at the 3<sup>rd</sup> Annual Choctawhatchee Estuary Family Festival on *May 1, 2010* at Rocky Bayou State Park. The first place prize is \$250, the second place prize is \$150, and the third place prize is \$100.

### **Image Modifications:**

Minor digital enhancement is permitted, but images that have been significantly modified or appear unnatural will be disqualified.

### **Not Permitted:**

- No borders or frames may be added to images.
- No watermarks, signatures, or copyright notices may be added to images. All winning images will be displayed with the photographer's name.
- Adding or replacing elements in an image is not permitted.
- Artistic filters are not permitted.

### Permitted Modifications:

- Images may be cropped and rotated as necessary as long as the rectangular format is maintained.
- Images may be resized as long as the aspect ratio is maintained so that prints can be made in size 8X10 inches.
- Red-eye removal and spot editing.
- One-step enhancement (such as "AutoFix", "QuickFix", "Auto Levels", etc.)
- Use of filters to sharpen, soften, blur, despeckle, or remove noise.
- Use of corrective functions to improve the natural appearance of the image, such as levels, contrast, brightness, curves, intensity, tone, hue, saturation, lightness, value, color balance, and tint.

## SUBMITTING ENTRIES

*Photographs must be submitted via electronic copy on CD.* Do not send negatives or prints. Attach a label to the CD with your name and address.
